### Quick Install Guide

Follow these instructions to install your InvisaPC DTX1000-T

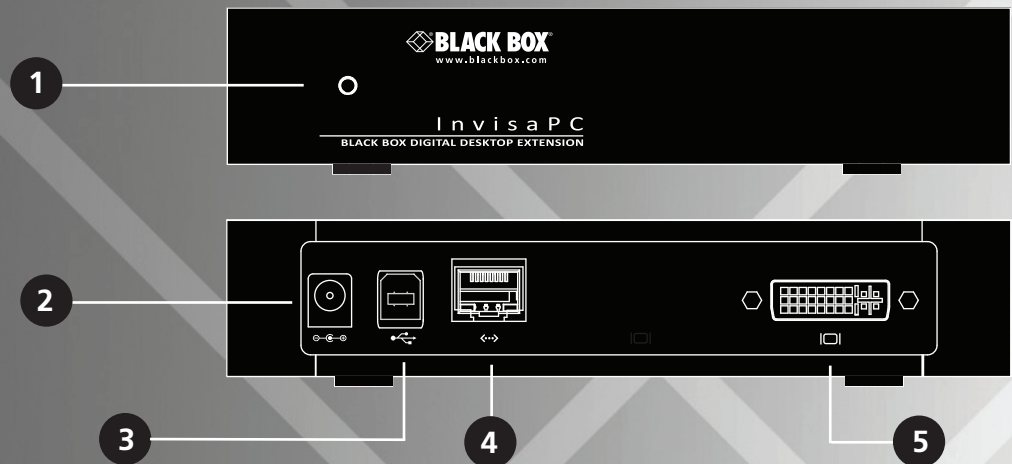

Figure A illustrates the front and back panel of the unit. Table A describes its components.

Table A - Front and Rear Panel Components

Number	Component	Description
1	Power LED	LED indicates power status.
2	5V DC Power in	Connect to supplied power adaptor
3	USB Connector	Connect to PC/Workstation USB connector
4	RJ-45 Port	Connect to LAN
5	DVI Video	Connect to PC/Workstation DVI Video output

## Connecting Power

Locate the power supply adaptor and AC line cord. Plug the DC connector of the power supply into the matching socket on the rear of the appliance. Attach the AC line cord to the power supply adaptor.

## Connecting the Peripherals

Attach the DTX1000-T to the target PC/Workstation using DVI and USB (Type B) cables. Connect to the LAN using standard CAT5 UTP cables between the RJ45 connector and the local network connection. The appliance works best with a 1 Gigabit connection.

## Starting up

Once everything is connected, apply power. The front panel LED will indicate power status. The DTX1000-T may be configured from a connected DTX1000-R Receiver. The default network setting for the unit uses a preconfigured Static IP address, 192.168.1.22.
